The Issues

Overnewton Anglican Community College comprises of two campuses, one at Keilor and the other at Taylors Lakes and consists of approximately 2000 students from Preparatory level to Year 12 across these two campuses.

Challenge

Overnewton aims to encourage and supports its students as individuals to achieve at optimum levels, aspires to maintain a happy, ordered environment and provide infrastructure that meets the requirements of their students. The challenge for SecureMonTM was to provide an adequate, effective and efficient security solution that could monitor and guard Overnewton's infrastructure and assets, which included school computers. SecureMon[™] was able to help Overnewton implement this solution in the short timeframe of a two-week school holiday break and before the Year 12's end of year celebrations of Schoolies Week. Additionally, as this was a novel solution for Overnewton, SecureMon[™] was able to incorporate an evolving scope.

The SecureMon[™] Solution

Fifty-five cameras were broadly dispersed over the two geographically distinct campuses

- These high resolution external cameras were able to monitor perimeter vulnerabilities
- Vandal-proof internal dome cameras that monitored internal susceptibilities were installed
- 10 Digital Video Recorders were distributed across both campuses and integrated into the existing IT infrastructure and configured for remote monitoring
- Although Overnewton had a local area network (LAN), they preferred not to place video traffic on the LAN, hence an analogue solution was deployed
- Scalable solution enabling future upgrades with minimum complications


